AUCTION NOTICE

Subject:- Disposal of old and condemned vehicles – regarding.

1. The High Court of Tripura is proposing to dispose of 3(three) Ambassador Cars on “as is where basis”. Details of the said vehicles are as under:-

2. Accordingly, sealed quotations are invited for disposal of the aforesaid vehicles on the terms and conditions mentioned below. Persons / firms, interested in purchasing the above-mentioned vehicles, may submit their highest quotations in the enclosed proforma in a sealed cover addressed to the undersigned latest by 04:00 PM on 22.03.2024 in the Registry of the High Court. The quotations received in time will be opened at 11:00 AM on 27.03.2024 in the Office Chamber of the Registrar(Admn. P & M), High Court of Tripura, Agartala. The bidders or their representatives, not more than one for each quotation, may be present, if they so desire, at the time of opening of Quotations. The cover should be prominently superscripted with the words

“QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE”.

3. The vehicles will be available for inspection between 03:00 PM to 04:00 PM on any working day from 06.03.2024 to 21.03.2024;

4. The Auction of the aforesaid vehicles will be governed by the following:-

I. The bidders are required to pay Earnest Money of Rs.5000/-(Rupees five thousand) only for each vehicle;

II.Earnest Money is payable by means of Demand Draft drawn in favour of the Registrar General, High Court of Tripura, Agartala (payment by cheque or cash shall not be accepted);

III.Quotations received without Demand Draft towards Earnest Money will not be considered and shall be rejected;

- IV. The successful bidder(s) will be required to deposit the bid amount by means of Demand Drafts drawn in favour of the Registrar General, High Court of Tripura, Agartala within 2(two) working days of the acceptance of the bid;
- V. The Earnest Money of the successful bidder(s) will be released only after the deposit of the bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if he / they fails/fail to honour the bid;
- VI. The delivery of the auctioned vehicles will be arranged only after the successful bidder submits documentary evidence in support of residential status (Aadhar Card, etc. in case of individual and Registration Certificate, etc, in case of firms);
- VII. The auctioned vehicles will be removed by the successful bidder within 2(two) working days of depositing the bid amount at their own expenses;
- VIII. The vehicles will be disposed off on “as is where basis” and no guarantee for its worthiness or quality will be given by the Registry;
- IX. The successful bidder(s) will also be responsible for getting the Registration Certificate of the vehicle transferred in his / her / their name(s) at his / her / their own cost expeditiously. The Registry will not be responsible for any lapse on his / her / their part in this regard.
- X. The bidders will not be allowed to withdraw their bids and if they do so, their Earnest Money will be forfeited;
- XI. The undersigned reserves the right to accept or reject any / all the Quotations without assigning any reason;
