**NOTIFICATION**

In exercise of the powers conferred under Article 225 of the Constitution of India, Section 28E of the North Eastern Areas (Re-organization) and other Related Laws (Amendment) Act, 2012 (Act No. 26 of 2012), Section 122 of the Code of Civil Procedure, 1908 and all other powers enabling it in this behalf, the High Court of Tripura do hereby makes the following rules further to amend the High Court of Tripura Rules, 2023 (herein after referred to as the 'Principal Rules') as follows:

**1. SHORT TITLE AND COMMENCEMENT:**

(1) These Rules may be called "THE HIGH COURT OF TRIPURA (3<sup>RD</sup> AMENDMENT) RULES, 2024."

(2) It shall come into force from the date of the publication in the Tripura Gazette.

**2. AMENDMENT OF RULE 6(3) OF CAPTION R OF CHAPTER VIII**

In the Principal Rules, the existing provision of Rule 6(3) of Caption R of Chapter VIII shall be substituted as follows:

"The costs shall be calculated at the following rates:

| Sl.No. | Particulars   | Amount |

| 01.    | Translation from Bengali to English for every page of the English translation or part thereof in connection with the preparation of Paper Book              | Rs.5/- |
| 02.    | Translation from any other language into English for every page of the English translation or part thereof in connection with the preparation of Paper Book | Rs.5/- |
| 03.    | Preparation of necessary number of copies of Paper Book for learned Counsels for every page or part thereof   | Rs.2/- |

Provided that four figures shall be treated as the equivalent of one word.”

### **3. AMENDMENT OF CAPTION G OF CHAPTER VIII**

In the Principal Rules, under Caption B of Chapter VIII, Rule 15 shall be inserted as follows:

“15. Period of Limitation:

The Period of Limitation for filing Review Petition against any order of Writ Proceedings shall be thirty (30) days with the power of condoning delay.”
