**NOTIFICATION**

In compliance of the Judgment dated 04.01.2024 of the Hon'ble Supreme Court of India in Writ Petition(Civil) No.643 of 2015(All India Judges' Association Vs. Union of India & Ors.), Hon'ble the High Court is pleased to notify the following Guidelines for Soft Loan Facility (Advance) for purchase of Car by Officers of Tripura Judicial Service:

**Guidelines for Soft Loan Facility (Advance) for purchase of Car by Officers of Tripura Judicial Service**

1. These Guidelines shall be called as "Guidelines for Soft Loan Facility(Advance) for purchase of Car by Officers of Tripura Judicial Service"
2. It shall come into effect from the date of its Notification.

**Entitlement:**

3. All serving Officers of Tripura Judicial Service shall be entitled to avail Soft Loan Facility (Advance) for purchase of Car in terms of these Guidelines.

**Loan/ Advance Amount:**

4. The maximum Loan/Advance amount to be provided to the Judicial Officers shall not exceed Rs.10,00,000/-.
5. The Loan/Advance amount is to be utilized to cover the purchase cost of a new or used Car.

**Interest Rate:**

6. The rate of interest on the Loan/Advance amount shall be at a fixed rate of 4% per annum and computation of interest shall be on the amount due after adjustment of the deposited amount.

**Repayment period:**

7. The Judicial Officer concerned can repay the Loan/Advance amount(along with interest accrued) in Equated Monthly Installment (EMI) to be deducted from his salary for a period ranging from minimum of Twelve(12) months to a maximum of Eighty-Four (84) months.

**Procedure:**

8. An Officer of Tripura Judicial Service desirous of availing Soft Loan/Advance for purchase of a Car (new or used) shall apply in writing to the High Court for such Loan/ Advance.

8.1. Such application shall inter alia contain the following particular(s):

(a) The amount of Loan/Advance sought.

(b) The period of repayment of such Loan/Advance.

(c) Make and model of the Car proposed to be purchased along with quotation in case of new Car.

9. On receipt of the said application, the Registry shall process it as expeditiously as practicable and place it before the competent authority for approval.

10. An arrangement shall be made with any Nationalized /scheduled Commercial/ Regional Rural Bank for providing such Soft Loan. After approval of loan by the authority, relevant papers shall be sent to the Bank branch for extending such loan. Law Department shall act as Nodal Department for providing interest subvention against such loan.

**Residuary Matter:**

11. Any other matter not covered by the above guidelines shall be placed before the Hon'ble High Court for approval/clarification/order as the case may be.
