N O T I F I C A T I O N

In exercise of the powers conferred by Article 229 of the Constitution of India, the Hon'ble Chief Justice of the High Court of Tripura, do hereby makes the following Rules further to amend the High Court of Tripura Services (Appointment, Conditions of Service and Conduct) Rules, 2014 (*herein after referred as the 'Principal Rules'*) :-

1. Short Title and Commencement:

- (i) These Rules will be called the "High Court of Tripura Services (Appointment, Conditions of Service and Conduct) (11th Amendment) Rules, 2024".
- (ii) They shall come into force with immediate effect.

2. Amendment of Rule 14:

Rule 14 of the Principal Rules shall be substituted with the following words:

"14. Promotion –

Promotion to the higher post/grade in all the cadres of the service shall be made on the basis of merit, merit-cum-seniority, seniority-cum-merit or seniority subject to rejection of unfit as specified in the schedules:

Provided that suitability test for promotion to certain posts may be taken as may be prescribed by the Chief Justice.

Notwithstanding anything to the contrary contained herein before, promotion to all Group–A Gazetted Posts of the High Court service is subject to Suitability Test to be taken by a Committee as may be constituted by the Chief Justice. The officials having "one very good" grading out of 03 ACRs shall only be considered for promotion. Character and integrity of the

Officials on the promotional fray has to be beyond doubt during the years of eligibility.”
