NOTIFICATION

In supersession of all earlier orders, directions and arrangements and in furtherance of the Notification dated 10.02.2026 issued by the High Court, whereby the affairs, assets, liabilities and administration of the Tripura Judicial Academy were vested in the High Court of Tripura pursuant to the dissolution of the Society, namely, "Tripura Judicial Academy", it is hereby notified that the Hon'ble Chief Justice, in exercise of the administrative powers, has been pleased to constitute a Board of Governors of the Academy with the following composition:

Member–Secretary to the Board

The Director, Tripura Judicial Academy shall function as the Member–Secretary to the Board of Governors and shall be responsible for convening meetings, maintaining records, implementing decisions of the Board of Governors and such other functions, as may be assigned.

Functions and Powers of the Board of Governors

The Board of Governors shall exercise overall supervision, control and governance over the functioning of the Tripura Judicial Academy and shall, *inter alia*, have power:

- (a) **to frame policies and guidelines** for the efficient functioning and governance of the Academy;
- (b) **to exercise administrative and financial control**, including approval of budget estimates, expenditure and procurement;
- (c) **to supervise establishment matters** including staffing pattern, recruitment and service conditions of employees, subject to applicable rules;
- (d) **to approve infrastructure development**, modernization, and asset management;
- (e) **to ensure institutional compliance with directions** issued by the Hon'ble Supreme Court of India, the National Judicial Academy and the High Court of Tripura in matters falling within the administrative and managerial domain of the Academy; and
- (f) **to perform such other functions** as may be necessary to achieve the objectives of the Academy.

Meetings of the Board

The Board of Governors shall meet at such intervals and in such manner as may be determined by the Hon'ble Patron-in-Chief or the President of the Board.

This notification shall come into force with immediate effect.
