## **SUBJECT: AWARD OF CONTRACT**

In response to the NIT No.F.33(2)-HC/2026/4715, dated 23.02.2026 for "Preparation of Stage with various components" in connection with the celebration of the 13<sup>th</sup> High Court Day on 04.04.2026 in the High Court premises 03 (three) bidders had participated in the bidding process.

After detailed scrutiny & evaluation of all aspects including technical and financial bids, the contract is awarded to the L1 bidder namely, Hero Deep Decorator & Catering Helpline, to execute the work.

To get the work order the Awardee shall submit an undertaking that it is bound to execute the work on 04.04.2026 instead of 21.03.2026.

However Award of contract is subject to the following Clause:

### **Clause: Cancellation of Work Order due to Government Order**

**If at any time during the currency of the contract, the Government of India/State Government/Competent Authority issues any order, notification, policy decision, or directive which makes it necessary to discontinue, suspend or modify the services covered under this Work order, the High Court reserves the right to cancel or terminate the Work Order partially or fully without any prior notice.**

**In such circumstances, the Agency shall not claim any compensation, loss of profit, or damage arising out of such cancellation or termination. The decision of the High Court in this matter shall be final and binding on the Agency.**
