NOTIFICATION

In exercise of powers conferred by Article 229 of the Constitution of India, Hon'ble the Chief Justice of the High Court of Tripura, do hereby makes the following Rules further to amend the High Court of Tripura Services (Appointment, Conditions of Service and Conduct) Rules, 2014 (*herein after referred as the 'Principal Rules'*):-

1. Short Title and Commencement:

- (i) These Rules shall be called the “**High Court of Tripura Services (Appointment, Conditions of Service and Conduct) (14th Amendment) Rules, 2026**”.
- (ii) They shall come into force with immediate effect.

2. AMENDMENT OF SCHEDULE-IV

The existing Schedule-IV of the Principal Rules shall be substituted with the followings:
