Pursuant to the letter dated 15.05.2026 of the Hon'ble Chief Justice of India vis-a-vis the Office Memorandum bearing F.No.01–04/2022–CBC (E 3203466) dated 12.05.2026, issued by the Government of India, Department of Personnel and Training, the Hon'ble High Court of Tripura has been pleased to direct inter-alia that the following austerity measures be taken in the District Judiciary of Tripura:

- (a) **Online hearing of cases be permitted to the extent it is feasible;**
- (b) **Accused persons be produced virtually, to the extent possible;**
- (c) **Meetings to be held, as far as possible, virtually, to avoid unnecessary travel for the purpose of the said meetings;**
- (d) **The possibility of online examination of official witnesses be explored, as far as possible;**
- (e) **Car pooling be adopted for travel to and from the place of work to the extent feasible.**
