**ORDER**

Pursuant to the decision taken by the Hon'ble Full Court in its Meeting dated 24.06.2026, the Hon'ble High Court has been pleased to direct that the following measures be taken in the High Court and District Courts of Tripura to reduce consumption of electricity :

- 1. Turn off all lights, fans and air conditioners when leaving rooms, chambers, cabins or courtrooms empty, or when not in use, as far as possible and feasible,**
- 2. As far as possible and feasible, set air conditioners to a standard temperature of 24°C or higher, as the case may be.**
- 3. Maximize natural light during daytime hours by opening blinds wherever possible and feasible.**
- 4. Power down computers, printers, scanners and photocopy machines at the end of the working day, or when not in use,**
- 5. Activate sleep mode on all electronic devices during lunch hours or extended breaks, or when not in use.**
- 6. Disconnect chargers from wall outlets once devices reach a full charge to prevent phantom power draw.**

Moreover to reduce consumption of fuel, in the High Court and District Courts of Tripura, the order No.F.44(11)(a)-HC/2026/12806, dated 20.05.2026, issued by the Registry of the High Court of Tripura shall be followed.
