**NOTIFICATION**

Hon'ble Supreme Court of India, vide communication dated 04.06.2026, has been pleased to emphasize the necessity of reflecting the Case Number Record (CNR) in all the Orders and Judgments and the use of standardized templates available in the Case Information System (CIS) for generation of Orders and Judgments.

The High Court of Tripura and the District Judiciary of Tripura are presently using Case Information System (CIS) Applications which are having the facility to generate standardized Order and Judgment templates containing the CNR as well as QR Code. Moreover, CIS Periphery Applications have been developed for the High Court of Tripura and the District Judiciary of Tripura facilitating easy and convenient generation of Order and Judgment templates containing the CNR, QR Code and other relevant case details.

In the aforesaid circumstances, Hon'ble The High Court of Tripura has been pleased to direct that:

- 1.** The CNR shall invariably be reflected in all Orders and Judgments passed by the High Court of Tripura and all the Courts of the District Judiciary of Tripura.
- 2.** The CIS Periphery Applications developed for the High Court of Tripura and the District Judiciary of Tripura may be used for generation of Order and Judgment templates containing CNR, QR Code and other relevant case details. The upgraded CIS periphery Application developed for the High Court of Tripura is accessible through the URL "**10.183.11.228/periphery/**" and the one developed for the District Judiciary of Tripura is accessible through the URL "**172.17.254.151/cnr\_template/**".
- 3.** This Notification shall come into force with immediate effect.
