NOTIFICATION

In exercise of the powers conferred by Article 229 of the Constitution of India, Hon'ble the Chief Justice of the High Court of Tripura with the approval of the Hon'ble Governor of the State of Tripura, does hereby make the following rules further to amend "The High Court of Tripura e-Courts Services (Appointment, Condition of Service & Conduct) Rules, 2013" namely-

1. Short title and Commencement:

(1) These Rules shall be called "The High Court of Tripura e-Courts Services (Appointment, Condition of Service & Conduct) (2nd Amendment) Rules, 2026."

(2) They shall come into force with immediate effect.
