N O T I F I C A T I O N

In exercise of powers conferred by Article 229 of the Constitution of India, Hon'ble the Chief Justice of the High Court of Tripura, do hereby makes the following Rules further to amend the High Court of Tripura Services (Appointment, Conditions of Service and Conduct) Rules, 2014 (*herein after referred as the 'Principal Rules'*):

1. Short Title and Commencement:

- (i) These Rules will be called the “High Court of Tripura Services (Appointment, Conditions of Service and Conduct) (17th Amendment) Rules, 2026”.
- (ii) They shall be deemed to have come into force with effect from 17.06.2014 i.e. the date when the High Court of Tripura Services (Appointment, Conditions of Service and Conduct) Rules, 2014 came into force.

2. Amendment of Schedule – I
